Message from the Master



This is my last Monthly Update as Master because on 7 July the honour passes to Master Elect Colin Drummond. June was busy, with the planting of a tree commemorating the Queen's Platinum Jubilee, the Tudor Pull commemorating the use of the River Thames as a highway for people and commerce, and the Election of two Sheriffs to serve the City in the Autumn. June Webinar

Professor Sean Comber, Associate Head SoGEES (Knowledge Exchange) Plymouth University presented our June webinar titled "Defra nutrient targets for improving river water quality: A personal assessment of the challenges and opportunities". DEFRA are proposing ambitious and farreaching targets for nutrient reductions in rivers by 2037, including an 80% reduction in phosphorus by 2037.

In his fascinating talk Professor Comber highlighted the need for better phosphorus measurement and gave his thoughts relating to options to reduce loads entering watercourses, their effectiveness and feasibility. Our next webinar will be in September after a summer break.

It was a splendid occasion on 9th June at Thorner's School in Dorset as the Water Conservators' Master Peter Hall planted a special tree and unveiled a plaque to commemorate the Platinum Jubilee with officers of the Company and Trust, plus the school children in attendance, who provided a musical finale.
