Message from the Master



The past month has been incredible - a genuine 'mensis mirabilis' - as readers of my Master's blog will know. On 28 February we had our Discussion Dinner with Rebecca Pow MP, Minister for Water, who was hugely impressed with the diverse range of skills and experience which our Company has to offer - and has since reached out to a number of us individually for input into the government's water strategy; it is no small thing to be specifically asked for advice in this way! Whittington600 Celebration

A service was held on 14th March at St Michael's Paternoster Roval to commemorate the 600th Anniversary of the death of Dick (Richard) Whittington. The service was led by The Rt Rev and Rt Hon Dame Sarah Mullally, Bishop of London. At the close a wreath was laid at Dick Whittington's memorial in the church. Afterwards there were presentations on the life and legacy of Dick Whittington by Professor Caroline Barron OBE and by our own Walbrook Warden, Professor Carolyn Roberts, notably highlighting Whittington's great contribution to the public health of the City. At the close Alderman Alison Gowman announced the City's 'Bin it don't block it' campaign, designed to address the scourge of sewer blockages and Alison paid specific tribute to the Water Conservators for our input and support.

City Water Debate

The topic for this year's WCWC City Water Debate, held on Tuesday 21st March, was "Does the governance of the water sector need to change to meet the requirements of the 2020s and 2030s, and, if so, how?" To discuss this, we welcomed the following expert speakers: Sir Dieter Helm CBE (Professor of Economic Policy at the University of Oxford), Alan Lovell DL (Chair of the Environment Agency), lain Coucher (Chair of the Office of Water Regulation), Lila Thompson (Chief Executive of British Water) and John Hirst CBE (Chair of Anglian Water).

As you might expect, views were many and varied, however there was agreement on many points: 1) something needs to be done, 2) action is required by all: water companies, regulators, farming and industry, the general public and government, and we need to work together, 3) a lot of investment will be required and we need to think urgently how this will be provided.
